
UPDATED CURRICULUM



SPECIALIZED TRAININGS

USING FEFE CURRICULUM IN A WORKSHOP FORMAT

FEFE has developed 60 minute workshop guides featuring “Take Charge of Your Finances” and “Get Ready to Take Charge of Your Finances” curriculum and active learning tools. The guides outline objectives, recommended facilitation and materials preparation for a variety of finance topics that can be used in the classroom, for community presentations, with student organizations or clubs, or for student-led projects. The 60 minute sessions include a balance of teaching content, allowing participants to practice skills learned in an activity based setting and finally reviewing new concepts. Workshops can be taught independently, or in a series of sixty-minute sessions with materials from both “Take Charge” and “Get Ready” depending on participant needs.

The top 5 requested workshop guides include:

- ★ Paychecks and Tax Forms
- ★ Credit
- ★ Spending Plans
- ★ Career Exploration
- ★ Saving

Workshop guides can be used by a variety of educators such as **Extension Agents, church group leaders, financial institutions, 4-H leaders, boy scout or girl scout mentors and students.** Workshops can be conducted as written in the overview, or edited to meet various needs by including additional active learning tools and/or enhancing or simplifying content.

SUMMER 2007 SPECIALIZED TRAININGS

FEFE conducts trainings in individual states and is preparing for a busy summer. Trainings range from one to three days and focus upon specific state and educator needs. Attendees are introduced to several “Take Charge of Your Finances” and “Get Ready to Take Charge of Your Finances” lesson plans and have the opportunity to experience multiple active learning techniques while networking with their peers. The following specialized trainings are currently scheduled:

LIFE OF... SIMULATIONS

OPTIONAL "TAKE CHARGE OF YOUR FINANCES" ASSESSMENT

"Life of..." is an individual spending plan simulation completed by analyzing the life of a teenager and developing a spending plan. The teenager's identity, family structure, income, and expenses are described in the Snapshot portion of the simulation, followed by major expenditure selections. Detailed instructions and guided discussion questions help students consider the teenager's values, goals, needs and wants, before making decisions to create a balanced spending plan. Once a zero balance achieved, students write an essay reflecting decisions made during the spending plan process.



A FEFE Master Teacher who challenged her students to create "Life of..." scenarios stated,

"Students really had to think in order to develop the new family and that it helped them to evaluate their own habits and to apply the financial concepts learned throughout the semester."

To develop a "Life of..." simulation requires mastery level knowledge of spending plans and how values, needs and wants influence an individual's decision making. **An optional assessment for students completing the "Take Charge of Your Finances" semester course is to develop a "Life of..." simulation featuring a new family identity with unique features and characteristics.** Students must carefully consider the family's income, how their lifestyle impacts spending plan decisions, the teenager's values and goals, and how he or she allocates his or her income to achieve those goals. Depending on available class time and assessment objectives, students can write only the Snapshot portion of the simulation, or develop an entire simulation by conducting research to identify appropriate housing, transportation and other choices for the teenager and his or her family. **A "Life of..." development guide and grading rubric is available to assist students when creating their individual spending plan simulation** and can be downloaded from <http://www.fefe.arizona.edu/curriculum.php?categoryID=32#209>.

AVAILABLE "LIFE OF..." SIMULATIONS

Three "Life of..." simulations are available showcasing teenagers with diverse family structures, values, part-time jobs, income, leisure activities and future goals. The diversity in simulations enables educators to select a simulation they feel their students will relate to best, thus creating a positive learning experience.

- ★ **Life of Taylor B. Jones** – Taylor is a student at North Shore high school, has a part-time job at Cubby's Restaurant & Grill, enjoys playing chess, and is a member of the local motocross club. Although he enjoys school, he is looking forward to attending a technical institute after graduation. Taylor's parents both work full time and his sister is in the fourth grade. As a family, the Jones' enjoy entertaining guests, attending sporting events and spending time with Taylor's grandparents.
- ★ **Life of Monica Erickson** – Monica attends Pebblebrook high school and enjoys her classes and socializing with her friends, but her favorite activity is participating on the culinary team. She dreams of having her own show on the Food Network and is looking forward to attending the Institute of Culinary Education. Monica is employed at Lucy's Luscious Cakes and Pastries and enjoys practicing her culinary skills at work. Monica and her mother live with her grandparents and the entire family enjoys spending leisure time together.
- ★ **Newly Developed Life of Ben West** – Ben is a high school student at WC Career and Technical Education Center studying mechanical and diesel services. He works part time for Lou's Logging Service and spends every minute of leisure time working on his dirt bike or snow boarding. Ben and his girlfriend Maria are saving their money to get married in the near future and enjoy volunteering to raise money for the local fire department. Ben's step-dad often works very long hours, his mom is a part time secretary and Anna, his little sister is three years old.
